PLEASE READ: Californía's Carbon Monoxíde Safety Law

Protecting California Families from the "Silent Killer"

In May 2010, an important public safety measure was signed into law requiring all California homes to be equipped with carbon monoxide alarms. Note: CO alarms are required IN ADDITION to smoke alarms and are not intended to replace them. Carbon monoxide (CO) is known as the "Silent Killer" because it is an odorless, colorless and tasteless gas that can catch its victims completely unaware. CO is the leading cause of accidental poisoning deaths in the United States and accounts for up to 700 emergency room visits in California each year. CO poisoning can cause severe and chronic brain, lung and heart injuries and can lead to death.

The only safe way to know if there is CO in your home is to arm your family with a working CO alarm.

The law enacts the Carbon Monoxide Poisoning Prevention Act of 2010 which requires that ALL residential properties be equipped with a Carbon Monoxide detector when the property has a fossil fuel burning heater or appliance, fireplace, and/or an attached garage. All single-family homes in structures with 1-4 units (owner or tenant occupied) must be equipped with a Carbon Monoxide detector on or before July 1, 2011.
